## PLANETARIUM PLANNED FOR WASHINGTON

As a part of the Southwest Redevelopment Program, a fine planetarium has been proposed by the owners of Hogate's Restaurant, Messrs. Watson and Joseph Roulon, who, according to the proposal, would also operate a large, new restaurant nearby. The 3 million dollar installation, which would occupy a tract originally designated as a park, would provide the Roulons with an obvious business advantage in return for the non-profit planetarium. Any surplus would be applied to an educational or research fund, and a plan is being considered to turn the planetarium over to the Smithsonian at some time in the future.

Instrumentation is expected to feature the large, versatile Model B, Spitz's finest, an example of which many NCA members enjoyed at the Yorklyn, Delaware laboratories of Armand Spitz, at his invitation last year.

Of the many proposals for a Washington planetarium which have been heard in past years, this one seems to offer the most feasible and acceptable plan. The trustees and officers of the NCA, having carefully considered the facts available to us, have decided to offer the endorsement of the NCA, and have accordingly addressed the Roulons, and the National Capital Park and Planning Commission in their behalf.

Incidentally, I have permission to quote Dr. Spitz as saying, "There will be quarters provided for the NCA."
